Susannah Randolph, Florida Watch Action: “Rick Scott – The Progressive’s Best Friend”

Have you heard about the “Pink Slip Rick” campaign? Do you remember the “Awake the State” rallies that took place around Florida this past March? Our November speaker, Susannah Randolph, is one of the driving forces behind these activist efforts.

Randolph spoke at the Sarasota County Democratic Party’s October meeting, and was greeted with such enthusiasm that we decided to invite her to share her story with the Club. Her firm, Florida Watch Action, an organization dedicated to strengthening the progressive movement in Florida, has received national coverage for its cutting edge branding campaign, “Pink Slip Rick.” The main purpose of the campaign is to drive down Governor Scott’s polling numbers, especially on the single issue of his campaign — jobs and the economy. The effectiveness of Randolph’s strategy can be measured by the appearance of Pink Slip Rick messaging in both Florida and national media, like *Hardball*, the *Ed Show*, the *Rachel Maddow Show* and *American Prospect Magazine*.

Randolph served as campaign manager for former Congressman Alan Grayson (D-Orlando). She is married to Florida State Representative Scott Randolph. They enjoy tennis, walks around Lake Eola, and saying the word “Uterus” in the company of Republicans. (If you don’t know what that means, join us on Nov. 12th to find out!)

Before we hear from Susannah Randolph, we’ll have the opportunity to welcome our first 2012 candidate, former Florida House Representative Keith Fitzgerald. Keith will provide opening remarks about his decision to take on Vern Buchanan next November.

Join us at the Laurel Oak Country Club on Saturday, November 12 to cheer Keith on and to learn some winning strategies from Susannah Randolph.

Last Month: LWV VP Pamela Goodman on Fair Districts

Updating attendees on the status of redistricting in Florida was the primary topic of October luncheon speaker Pamela Goodman, First Vice President of the League of Women Voters (LWV) of Florida and Chair of their Fair Districts effort. But Goodman also took the opportunity to warn us about HB 1355, the elections law passed during the 2011 Florida Legislative Session that voting rights advocates are calling the “Voter Suppression Law.”

Background on Fair Districts

Fair Districts Now is a nonpartisan coalition of rights organizations in Florida which includes the ACLU, Common Cause, the LWV and the NAACP. Goodman said the LWV has

been working for 52 years for fair districts in what she called “one of the most gerrymandered states” in the US. After spearheading an effort to collect over 1.6 million petition signatures and winning a court challenge on wording, Fair Districts won passage of Amendments 5 and 6 on the 2010 ballot with 3.1 million Floridians voting “yes.”

Despite voters’ overwhelming support, forces opposed to Fair Districts are still engaged in “shenanigans” to prevent full implementation. In one of the seven legal challenges against the fair districts amendments, two US Representatives claimed that

Florida ACLU is taking Rick Scott to Court to Protect Rights

Howard Simon, Executive Director of ACLU Florida, gave a wide-ranging talk at the Sarasota County Democratic Party October meeting on current threats in Florida to voting rights, workers' rights, women's rights, privacy right and religious freedom. Simon admitted, however, that Rick Scott's policies had led to the creation of several new jobs — in the ACLU office. Simon had added more lawyers to his staff to handle lawsuits against Scott and the Florida Legislature.

In discussing HB 1355, Simon said the Legislature ultimately admitted that the voting fraud the reforms were aimed at

addressing was really nonexistent. Simon asserted that elections are really determined by the rules that are set months ahead of time. Apparently the Republican-led Legislature is setting the rules to favor Republicans in 2012 and beyond.

Simon identified the role of the ACLU in elections as making "sure the brick wall that is the US Constitution protects the people." Of the eight lawsuits they've filed so far against the governor and/or the legislature, the ACLU has won three and is optimistic about the others.

Amendment 6 violated the US Constitution. Because their suit was against language that is now part of the Florida Constitution, the Florida Secretary of State is defending the measure — at taxpayer expense. At the same time, the Florida House of Representatives joined the suit opposing the measure — again, at taxpayer expense. At a hearing in September, the judge quickly ruled in favor of Amendment 6. But, within days, an appeal was filed and the Florida House joined the appeal, forcing Florida taxpayers to pay the legal costs on both sides of the suit. When House Rep. Scott Randolph (D-Orlando) asked how much taxpayer money had been spent, the leadership refused to answer.

Pamela Goodman said we must maintain “a permanent sense of outrage” to sustain the fight.

Status of Redistricting

Public hearings were completed in August, with the final one, in Sarasota, prompting a scolding from Sen. Nancy Detert because attendees complained about not having proposed maps to comment on, the use of taxpayer money to fight the will of the voters, and delays in the process which put the 2012 election in jeopardy.

The Senate Redistricting Committee said it will publish its proposed maps on Dec. 5, but no information was provided on opportunities for public feedback.

Goodman said we must keep the issues in the press and in front of legislators. She believes public outcry will influence the judges if Fair Districts finds it necessary to challenge new district lines. The judge could either personally redraw the lines, or refer them back to the legislature for correction. If new Congressional districts aren't ready in time, the 2012 election could be held using the 2010 districts, and adding the two seats Florida gained from the Census as At-Large positions.

Florida HB 1355: “Voter Suppression Law”

Goodman reported that election laws were changed throughout the US in states with Republican majorities in the legislature and Republican governors. The wording of the new laws was almost identical in each state. The provisions of these laws will reduce participation of minorities, women and young voters in elections.

The LWV of Florida has been criticized for opting to discontinue its voter registration efforts because of this law. As Goodman explained the law's provisions, the LWV decision was understandable. Failure to comply with onerous administrative procedures could result in felony charges against LWV volunteers and large fines against the organization. However, the LWV could resume voter registration after it sees how the law is actually implemented. (OFA, the Obama for America campaign, has developed a method of registering voters while complying with the law. Training sessions are being offered at Sarasota County Democratic Party headquarters.)

Meigs Glidewell: A Living Legacy

Meigs Glidewell has written 65 books that nobody wants to read. That's because they are users' manuals for 13 computer operating systems, 12 of which are no longer in use. But she has also written jokes for Phyllis Diller and Joan Rivers, and she currently publishes an email cribsheet before elections telling a few hundred close friends "you know me and my values, and here's how I intend to vote."

That political involvement began at a rally for Gore/Lieberman which led her to the Sarasota County Democratic Party and this Club. She now works for individual candidates, phones for the Party, and is a regular at Club lunches "for the fun and the good speakers." She's also vice-president of Sarasota/Manatee chapter of the National Organization for Women (NOW) founded during the early push to ratify the Equal Rights Amendment.

Comedy is another theme in Meigs's life. She wrote her own material as a stand-up comic and now pursues cartooning and public speaking with Toastmasters. A major activity is offering workshops on speaking, giving attendees twenty-six different exercises to change their sound. Meigs has given these programs to students at Fruitville Elementary and North Sarasota Library; they are available to other groups and individually. She also offers workshops on "Listening" and on "How to Rant," the latter on the theory that if you know how to do it you are less susceptible to being intimidated by a rant.

Meigs and her husband, a Philosophy of Science Professor now a registered investment advisor (RIA), publish a newsletter on the technology and computer fields and advise on investment portfolios in those areas.
