JANUARY LUNCHEON PROGRAM

Tampa Mayor Bob Buckhorn

The political prognosticators predict that Florida's I-4 corridor will determine the winner of the state's electoral votes in 2012. The city of Tampa is a key point on that corridor. It is also the dominant television market in our area — and crucial for candidates, like Keith Fitzgerald, who need to reach voters outside our immediate Sarasota vicinity.

In addition to being the largest television market in Florida (even larger than Miami), Tampa is the business, education, sports, and transportation capitol of the area. Our luncheon speaker on Saturday, January 14 is Tampa's highest profile leader, Mayor Bob Buckhorn — the Democrat who won a runoff in a landslide last March. Buckhorn took office in the third year of a recession and is now preparing the city to be under an international spotlight when the Republican National Convention convenes in Tampa in August 2012. With less than a year in office, he is turning Tampa into a place that is on the

move, focused on strengthening neighborhoods, and is committed to economic development.

Sarasota Democrats can take pride in the fact that, even though we couldn't vote in the Tampa election, volunteers at Sarasota Democratic Party headquarters played a role in the Mayor's victory by making hundreds of phone calls to urge Tampa residents to vote for him.

Carroll Buchanan

Educator, musicologist, civil rights and human rights advocate, Peace Corps volunteer, history buff, actor and active Democrat, S. Carroll Buchanan Ph.D. was a modern-day Renaissance Man. While the range of his interests and talents was wide, one thing tied them all together — community service.

In the twenty years that Carroll called Sarasota home, he founded and led the Gulf Coast Community Choir, a multicultural chorus whose performances raise funds for local charities, co-founded Embracing Our Differences, an annual event on the bayfront combining words and billboard-size art to convey how

Vote By Mail is Key to Winning in 2012

Did you Vote By Mail in 2010? Have you renewed your request to Vote by Mail in 2012? Have you urged your Democratic friends to sign up to Vote by Mail? If you answered “no” to any of those questions, you need to read the following.

Voting by mail — also known as Absentee voting — can spell the difference between Democrats winning or losing an election. An absentee ballot is practically a “guaranteed vote.” Over 90% of absentee ballots that are requested are voted. Compare that with the 56% overall voter turnout in 2010 and you’ll understand why both political parties encourage their stalwarts to Vote By Mail. Right now, Sarasota Republicans are winning the race to sign up absentee voters.

To make matters even worse, the Republican-dominated Florida Legislature passed HB 1355 last year. This “Voter Suppression Act” makes it more difficult to vote in person — something that Democrats tend to do — but doesn’t interfere with voting by mail — the way Republicans tend to vote.

Because so many of us moved from other states with different laws concerning absentee voting, there’s lots of misinformation about it. Here’s some clarification of the facts:

Fiction: Absentee ballots aren’t counted unless the results are close. Not True. Under Florida law, the Supervisor of Elections (SOE) must include the absentee balloting results in its first report of “unofficial” results to the Florida Division of Elections. The SOE may begin counting absentee ballots 4 days before Election Day, although results may not be released until after the polls close.

Fact: All Florida voters may sign up to Vote by Mail. Voting by mail is the same as absentee voting. Florida law now permits all voters to request absentee ballots. The request must be renewed after each General Election.

Fiction: You can’t be sure your Absentee Ballot was received. Not True. You can check the status of your absentee ballot on the Internet at <http://registration.elections.myflorida.com/>. On this site, you can make sure your voter registration is current, request an absentee ballot, see when your ballot was mailed to you, and see when it was received by the SOE.

Fact: You have to pay postage to mail your absentee ballot. An insert in your ballot envelope will indicate how much postage is required. Or your ballot can be hand-delivered to the SOE office any day during business hours up until the polls close on Election Day. (You may not return it to your polling place on election day, but you can exchange it for an in-person ballot.)

Fiction: It’s difficult to request an Absentee Ballot. Not True. There are 5 ways. Pick the one that’s easiest for you.

1. Telephone: Call the SOE at (941) 861-8618 and provide your name, date of birth, registration address, and where the ballot is to be mailed.
2. Email: Send your request to absentee@sarasotavotes.com with the same information.
3. Mail: Mail a letter or an official “Ballot Request Form” to PO Box 4194, Sarasota FL 34230-4194.
4. Fax: Fax your letter or a completed “Ballot Request Form” to (941) 861-8617.
5. Online: Go to <http://registration.elections.myflorida.com/>

diversity enriches our lives, and established an ASALH film series at North County Library to screen enriching and inspiring films that depict all aspects of the African American experience. Carroll's contributions to Democrats' success included serving as a precinct committeeman in The Meadows and on this club's board.

More important was Carroll's personal challenge to all he met — but especially to young people — to look beyond accepted wisdom and to strive beyond expectations.

Adam Tebrugge

For 23 years, Adam Tebrugge was a public defender, eventually becoming the chief trial attorney in the homicide division. For many of us, Adam was the public face of the Public Defender's office — the attorney we saw on the news representing people on trial for the worst crimes. But Adam's image was never tarnished by the defendants he stood beside because he saw his job as one of community service — making justice work for everyone, regardless of their ability to pay.

Now in private practice, Adam continues to be a resource for others: consulting in difficult criminal cases, hosting a local television show on legal issues, and teaching a Death Penalty Seminar at Stetson Law School.

Serving as Chairman of the Board of the Suncoast Partnership to End Homelessness, Adam is also an advocate for the homeless. He has been educating community groups on the nature of homelessness in Sarasota and Manatee Counties, and building support for implementation of a soon-to-be-released 10 Year Plan to End Homelessness locally.

Many would find dealing with crime and homelessness on a daily basis depressing, but Adam usually greets us with a smile. Perhaps it's a reflection of how much good he is doing in Sarasota.

Dick Stammer: A Living Legacy

Dick Stammer has retired twice, but is now fully engaged in a third, if volunteer, career — working to build up our Democratic Party for victory in the 2012 elections. He is so concerned about what is happening now, he feels it imperative to fight off what may happen then.

With a degree in English, Dick was setting out for graduate work preparatory to college teaching when he decided suddenly to see what social service work was like. On his first day on the job he met Diane — the girl he married — and he never left the field. Dick spent 14 years in direct child welfare services, and then, with a Masters in Public Administration, another 16 years in administration and advocacy. His particular pride is helping direct the statewide board of child welfare volunteers and their liaison with the legislature to promote and support better laws and policies.

Retiring with Diane to Sarasota, he worked six years for Florida, primarily in Adult Protective Services, assisting and advocating for those 18 and over who are vulnerable through disability, handicap, frailty, abuse, neglect or exploitation. Ours is a large population “waiting to be plucked,” he says, with family members often the worst exploiters.

Dick and Diane were both active Club members, and her death after 35 years of marriage left him deep in grief. With the help of the Wellness Community and many friends he has returned to activity for the Democrats and cycling 100 miles a week with the Sarasota-Manatee Bicycle Club. Working for the Sarasota County Democratic Party, his emphasis is on building up precincts, developing a more lasting organizational structure, identifying leaders, drawing in new members, and making new voters welcome and involved.
