## JANUARY LUNCHEON PROGRAM Barbara Ford-Coates—"The REAL ID Act, Drivers Licenses & How it Affects You"

Four years after the 9/11 terrorist attacks, President George W. Bush signed the REAL ID law. While the wellintended law was designed to weed out fraud in driver licensing, the new requirements are so strict that many long established citizens find themselves caught up in overwhelming bureaucratic complexity.

Join us on Saturday, January 12th, as we welcome Sarasota County Tax Collector Barbara Ford-Coates to educate us on the reality Floridians face as the REAL ID law is fully implemented. She will provide us with details on why the law was passed and who it impacts, as well as how, when, and where Floridians must comply. With local governments facing the many challenges of implementation, she will share what her office is doing to make compliance as painless as possible.

A native of Virginia, Barbara Ford-Coates has lived in Sarasota County since 1972. She joined the Tax Collector's office in 1975. She was first elected to the top position in 1984 and re-elected in 1996, 2000, 2004, 2008,

and 2012 without opposition. She is the longest serving Sarasota County elected official and the recipient of the 2008 Outstanding County Tax Collector in the United States award. She is a Democrat who is active with the League of Women Voters, on the board of the Community Foundation, and is a Girl Scout Troop leader.

# Last Month: Mayor Suzanne Atwell & the Gulf Coast Community Choir

Mayor Suzanne Atwell addressed the Democratic Club at our December holiday luncheon. She opened with, "President Barack Obama was reelected President of the United States and all is right with the world".

Elected to the Sarasota city commission in 2009 and twice selected by her peers to act as Mayor, she spoke of her love of her job and her optimism about the new generation of city staff, including City Manager, Tom Barwin, and the first woman Chief of Police in over a 100 years, Bernadette Kapino from Ocean City, MD.

Touching on the homelessness issue,

she stated that we need to work on solutions that are applicable now and shared that the new interim police chief, Captain Paul Sutton, along with the city manager, has convened a homelessness task force to look at a more centralized solution to curb the flight of the homeless from one neighborhood to another.

Other topics included the importance of collaborating with our sister municipalities and counties to develop sustainable and renewable energy resources and the twenty year agreement that the city recently entered with Braden River Utilities to provide two million gallons of reclaimed water to Lakewood Ranch for irrigation.

Mayor Atwell acknowledged that tensions often exist between those advocating for neighborhood preservation and the business (Continued on page 3)
